

Who can use this form?

People with Medicare who want to join a Medicare Advantage Plan

To join a plan, you must:

- Be a United States citizen or be lawfully present in the U.S.
- Live in the plan's service area

Important: To join a Medicare Advantage Plan, you must also have both:

- Medicare Part A (Hospital Insurance)
- Medicare Part B (Medical Insurance)

When do I use this form?

You can join a plan:

- Between October 15–December 7 each year (for coverage starting January 1)
- Within 3 months of first getting Medicare
- In certain situations where you're allowed to join or switch plans

What do I need to complete this form?

- Your Medicare Number (the number on your red, white, and blue Medicare card)
- Your permanent address and phone number

Reminders:

- If you want to join a plan during fall open enrollment (October 15–December 7), the plan must get your completed form by December 7.
- Your plan will send you a bill for the plan's premium. You can choose to sign up to have your premium payments deducted from your bank account or your monthly Social Security (or Railroad Retirement Board) benefit.

Paying Your Plan Premium:

For the BlueMedicare Patriot and Value Plans: If we determine that you owe a late enrollment penalty (or if you currently have a late enrollment penalty), we need to know how you would prefer to pay it. You can pay by mail or Electronic Funds Transfer (EFT) each month. You can also choose to pay your premium by automatic deduction from your Social Security or Railroad Retirement Board (RRB) benefit check each month. If you are assessed a Part D-Income Related Monthly Adjustment Amount, you will be notified by the Social Security Administration. You will be responsible for paying this extra amount in addition to your plan premium. You will either have the amount withheld from your Social Security benefit check or be billed directly by Medicare or the RRB. DO NOT pay the Part-D IRMAA to BlueMedicare Value or BlueMedicare Patriot.

For the BlueMedicare Choice and Select Plans: You can pay your monthly plan premium (including any late enrollment penalty that you currently have or may owe) by mail or Electronic Funds Transfer (EFT) each month. You can also choose to pay your premium by automatic deduction from your Social Security or Railroad Retirement Board (RRB) benefit check each month. If you are assessed a Part D-Income Related Monthly Adjustment Amount, you will be notified by the Social Security Administration. You will be responsible for paying this extra amount in addition to your plan premium. You will either have the amount withheld from your Social Security benefit check or be billed directly by Medicare or the RRB. DO NOT pay the Part-D IRMAA to BlueMedicare Choice or BlueMedicare Select.

People with limited incomes may qualify for Extra Help to pay for their prescription drug costs. If eligible, Medicare could pay for 75% or more of your drug costs including monthly prescription drug premiums, annual deductibles, and co-insurance. Additionally, those who qualify will not be subject to the coverage gap or a late enrollment penalty. Many people are eligible for these savings and don't even know it. You can also apply for Extra Help online at www.socialsecurity.gov/prescriptionhelp.

If you qualify for Extra Help with your Medicare prescription drug coverage costs, Medicare will pay all or part of your plan premium. If Medicare pays only a portion of this premium, we will bill you for the amount that Medicare doesn't cover.

If you don't select a payment option, you will get a bill each month.

Please Read This Important Information

If you currently have health coverage from an employer or union, joining BlueMedicare Choice, BlueMedicare Patriot, BlueMedicare Select or BlueMedicare Value could affect your employer or union health benefits. You could lose your employer or union health coverage if you join BlueMedicare Choice, BlueMedicare Patriot, BlueMedicare Select or BlueMedicare Value. Read the communications your employer or union sends you. If you have questions, visit their website, or contact the office listed in their communications. If there isn't any information on whom to contact, your benefits administrator or the office that answers questions about your coverage can help.

Attestation of Eligibility for an Enrollment Period

Typically, you may enroll in a Medicare Advantage plan only during the annual enrollment period from October 15 through December 7 of each year. There are exceptions that may allow you to enroll in a Medicare Advantage plan outside of this period.

By completing this enrollment application, I agree to the following:

I understand that my response to this form is voluntary. However, failure to respond may affect enrollment in the plan.

BlueMedicare Choice, BlueMedicare Patriot, BlueMedicare Select and BlueMedicare Value are Medicare Advantage plans and have contracts with the Federal government. I will need to keep my Medicare Parts A and B. I can be in only one Medicare Advantage plan at a time, and I understand that my enrollment in this plan will automatically end my enrollment in another Medicare health plan or prescription drug plan. It is my responsibility to inform you of any prescription drug coverage that I have or may get in the future. Enrollment in this plan is generally for the entire year. Once I enroll, I may leave this plan or make changes only at certain times of the year when an enrollment period is available (Example: October 15 - December 7 of every year), or under certain special circumstances.

BlueMedicare Choice, BlueMedicare Patriot, BlueMedicare Select or BlueMedicare Value serve specific service areas. If I move out of the area that BlueMedicare Choice, BlueMedicare Patriot, BlueMedicare Select and BlueMedicare Value serves, I need to notify the plan so I can disenroll and find a new plan in my new area. Once I am a member of BlueMedicare Choice, BlueMedicare Patriot, BlueMedicare Select or BlueMedicare Value, I have the right to appeal plan decisions about payment or services if I disagree. I will read the Evidence of Coverage document from BlueMedicare Choice, BlueMedicare Patriot, BlueMedicare Select or BlueMedicare Value when I get it to know which rules I must follow to get coverage with this Medicare Advantage plan. I understand that people with Medicare aren't usually covered under Medicare while out of the country except for limited coverage near the U.S. border.

I understand that beginning on the date BlueMedicare Choice, BlueMedicare Patriot, BlueMedicare Select or BlueMedicare Value coverage begins, using services in-network can cost less than using services out-of-network, except for emergency

or urgently needed services or out-of-area dialysis services. If medically necessary, BlueMedicare Choice, BlueMedicare Patriot, BlueMedicare Select or BlueMedicare Value provides refunds for all covered benefits, even if I get services out of network. Services authorized by BlueMedicare Choice, BlueMedicare Patriot, BlueMedicare Select or BlueMedicare Value and other services contained in my BlueMedicare Choice, BlueMedicare Patriot, BlueMedicare Select or BlueMedicare Value Evidence of Coverage document (also known as a member contract or subscriber agreement) will be covered. Without authorization, **NEITHER MEDICARE NOR BLUEMEDICARE CHOICE, BLUEMEDICARE PATRIOT, BLUEMEDICARE SELECT OR BLUEMEDICARE VALUE WILL PAY FOR THE SERVICES.**
